Powers and Functions of the Committee: -

- 1. The Child Welfare Committee shall exercise the powers and discharge the duties conferred in relation to children in need of care and protection under the Act.
- 2. The Committee shall function as a Bench of Magistrates and shall have the powers conferred by the Code of Criminal Procedure, 1973 on a Judicial Magistrate of the first class.
- 3. The Committee shall meet at such times and shall observe such rules of procedure in regard to the transaction of business at its meeting as may be prescribed.
- 4. A child in need of care and protection may be produced before a Chairperson/Individual Member for being placed in safe custody or otherwise when the Committee is not in session.
- 5. The Committee shall have the final authority to dispose of cases for the care, protection, treatment, development and rehabilitation of the children as well as to provide for their basic needs and protection of human rights.
- 6. Notwithstanding anything contained in any other law for the time being in force but save as otherwise expressly provide in this Act, the Committee shall have the power to deal exclusively with all proceedings under the Act relating to children in need of care and protection.
- 7. The Committee shall hold its sitting in a child friendly premises which shall not look like a Court room in any manner and the sitting arrangement should be such to enable the committee to interact with the child face to face.
- 8. The committee shall submit a quarterly report on the nature or disposal of cases and pendency of cases to the District Magistrate in the manner as may be prescribed in the Form 16, for review of pendency of cases.
- 9. The District Magistrate shall be the grievances redressal authority for the Child Welfare Committee and any one aggrieved by the Child Welfare Committee's decision, may file a review petition before a District Magistrate, who shall review and pass appropriate order.

Tenure

The Committee shall have a term of 3 (three) years with effect from the date of issue of notification and the appointment of members shall be coterminus with the tenure of the Committee.

However, Government may change the composition of the committee or change the Members of the committee anytime, if considered necessary.

Sitting

The Committee shall meet at least twenty days in a month and shall observe such rules and procedures with regard to the transaction of business at its meetings, as may be prescribed.
