FUNCTIONS OF THE COMMITTEE

- a. Provide overall oversight for implementation of the State Action Plan under National Action Plan for Drug Demand Reduction (NAPDDR) and Nasha Mukta Bharat Abhiyaan (NMBA).
- b. Ensure achievement of annual and quarterly targets related to awareness generation, treatment, rehabilitation, counselling, capacity building and other relevant areas of action for drug demand reduction in the State.
- c. Ensure integration of drug demand reduction activities into existing State programmes and schemes.
- d. Review outreach activities conducted in educational institutions, villages, wards, vulnerable communities etc.
- e. Monitor implementation of NMBA and observance of key national events related to substance abuse prevention with an aim to reach more and more people.
- f. Review availability and functioning of Integrated Rehabilitation Centres for Addicts (IRCA), District De-addiction Centres (DDACs), Addiction Treatment Facilities (ATFs) and other treatment facilities.
- g. Address gaps in accessibility and quality of treatment services.
- h. Identifying high risk Districts and approved focussed intervention plans.
- i. Review District performance against performance indicators.
- j. Facilitate optimal utilisation of Central and State resources for prevention, treatment and rehabilitation activities.
